NOTICE IS HEREBY GIVEN THAT THE BOARD OF DIRECTORS OF ROCKETT SPECIAL UTILITY DISTRICT OF ELLIS AND DALLAS COUNTIES, TEXAS, WILL MEET AT THE OFFICE OF ROCKETT SPECIAL UTILITY DISTRICT, 126 ALTON ADAMS DRIVE, WAXAHACHIE, TEXAS, ON TUESDAY JANUARY 15, 2019, AT 7:00 PM TO CONSIDER THE FOLLOWING MATTERS.

9. Discussion and possible approval of Ordinance 2019-003, and Ordinance of Rockett Special Utility District, Ellis and Dallas Counties, Texas, amending and restating section G.2 of the District's Rate Order relating to Service Investigation Fees; and providing for an effective date.
10. Discussion and possible approval of the Non-standard Service Contract by and between Rockett Special Utility District and Countryview of Red Oak, LLC (Oakmont Park).
